2. VIRTUAL COMMITTEE AND COUNCIL/BOARD MEETINGS

Due to the COVID-19 pandemic, ECTA took the decision to postpone the Annual Conference in Copenhagen initially planned for June 2020 and hold all internal meetings in a virtual format. From 12 to 19 June 2020, we have held a successful virtual Management Committee Meeting, meetings of all ECTA Committees and Task Forces, as well as a productive virtual Council/Board Meeting on 17 June 2020, where the Presidency changeover and Management Committee rotation took place.

The first ever virtual AGM of both the European Communities Trade Mark Association (ECTA) (which is winding down) and ECTA AISBL (the successor association based in Belgium) took place on 18 June 2020 and was attended by a high number of members interested in the progress of the association and learning more about strategic, structural, financial, and other current topics and changes.





3. ECTA WEBINARS

ECTA was pleased to provide in a webinar format two learning sessions, originally scheduled for the Annual Conference in Copenhagen, on the following IP topics:

- Powering up. Using new technologies in the IP environment (9 June 2020)
- Parallel Imports: How important is a trade mark? A limitless sea? Pharma perspective (11 June 2020)

Many participants, both members and non-members, attended our webinars and gave us positive feedback on the overall experience, high level of speakers, learning opportunities and smooth organization of these events. We would like to thank our **distinguished speakers** - Chairs of ECTA Committees, officials from EU bodies, IP professionals from industry and private practice - for agreeing to provide our attendees with their valuable insights on these important topics. We very much appreciated the willingness to adapt to a different format than the one initially planned.

4. COUNCIL/BOARD ELECTIONS AND ROTATION

The policy of the association is managed by the Council/Board who, being the elected body of the association is the only body which is fully representative of the membership. Council/Board members are elected for a two-year term and may serve on the Council/Board for four consecutive terms, i.e. a total number of eight years. After a break of two years, it is possible to re-apply to become a Council/Board member.

In June, both ECTA and ECTA AISBL held **online elections** for the countries where more nominations than vacant seats were received, namely for Austria and Italy, and all ordinary members were invited to vote. For the countries where one nomination per vacant seat was received, the elections took place at the AGM (Annual General Meeting) on 18 June 2020.

ECTA welcomes the new Council members and is grateful for their willingness to participate more actively to the work of the association. We would also like to thank all the Council/Board members who are stepping down, for their loyalty and contribution to ECTA over the past years.
