1. INTRODUCTION: THE COMMISSION NOTICE

- Commission notice on the customs enforcement of IPR concerning goods brought into the customs territory of the Union without being released for free circulation including goods in transit [2016] OJ C244/4
- Addressed to the MS's customs administrations
- ➤ Replaces the February 2012 Guidelines
- Not legally binding



2. ENTRY INTO EFFECT OF THE NEW PROVISIONS

- > Article 9(4) EUTMR: 23 March 2016
- Article 10(4) NTMD: to be implemented by 14 January 2019




3. A TRADE MARK 'WHICH IS IDENTICAL OR CANNOT BE DISTINGUISHED IN ITS ESSENTIAL ASPECTS'

- 'Identical'
 - CJEU, Case C-291/00 LTJ Diffusion
 - "a sign which either reproduces, without any modification or addition, all the elements constituting the protected trade mark or which, viewed as a whole, contains differences so insignificant that they may go unnoticed by an average consumer"
- 'Which cannot be distinguished in its essential aspects'
 - Even if the sign would contain differences which would not go unnoticed by an average consumer



Scope of trade mark protection as regards the degree of similarity between the signs at issue:

4. 'ENTITLED TO PROHIBIT THE PLACING OF THE GOODS ON THE MARKET IN THE COUNTRY OF FINAL DESTINATION'

- Requires trade mark protection in the country of destination?
 - Article 9(4) EUTMR & Article 10(4) NTMD: unclear
 - EC Notice: yes
 - Legislator's intent:
 - Ubi lex voluit, dixit; ubi noluit, tacuit?
 - Recitals 17 EUTMR & 23 NTMD: strike a balance between 'the need to ensure the effective enforcement of <u>trade mark rights</u>' and 'the necessity to avoid hampering the free flow of trade in legitimate goods'

4. 'ENTITLED TO PROHIBIT THE PLACING OF THE GOODS ON THE MARKET IN THE COUNTRY OF FINAL DESTINATION' (CONT'D)

- Onus of proof >< Articles V and XX(d) of GATT?
 - Postive fact: country of final destination
 - Negative fact: lack of protection there
 - ⇒ Disguised restriction on legitimate trade in the sense of Article XX?
- Registered and unregistered trade marks?
 - Cf. Art. 6bis Paris Convention, common law rights in a trade mark acquired through use, pending applications,...
 - Expression 'validly registered' in draft compromise text tabled by the EP was eventually deleted



5. ARTICLE 17(2) OF REGULATION 608/2013

- Possibility for Customs, before detaining the shipment, to request any information about the goods
 - Also lists of trade marks in non-EU countries?
 - Max Planck Institute 2010: RO should provide proof of IPR in AFAs 'for all pertinent jurisdictions'



5. ARTICLE 17(2) OF REGULATION 608/2013 (CONT'D)

PRO:

- Avoid impediments to legitimate trade
- Resources

CONTRA:

- Impracticable
- 'about the goods'?
- How about unregistered trade marks?
- Inconsistent with Articles 9(4) EUTMR/10(4) NTMD
- Inconsistent with Article 6 of Regulation 608/2013

ALTING

6. MEDICINES

- customs should 'take all reasonable care to ensure that legitimate legally traded medicines, whether or not generic, can be routed through the customs territory of the Union'
 - 'Legitimate legally traded medicines' includes, inter alia, 'medicines in mere transit through the EU territory, covered by a patent right applicable to such medicines in the EU territory, without adequate evidence of a substantial likelihood of diversion of such medicines onto the EU market'
 - Scope of recital 11 of Regulation 608/2013?



6. MEDICINES (CONT'D)

'customs authorities should take full precautions to avoid any detention of medicines under Regulation (EU) No 608/2013, unless they are intended for the EU market or unless those goods bear a trade mark suspected of being identical or essentially identical to the protected trade mark'
