- TRADE MARKS LEGISLATION FROM THE COLONIAL TIMES – CAP 268
- Decision to Modernise not only the Law but also the procedures
- Modification in existing electronic filing systems pertaining to the implementation of the transposition

- Multi-Class Applications
- New types of Marks
 - e.g sound marks, colour marks, shape of products
- 10 Years Duration 10 Years Renewal





- Evidence of 5 Years use as a preliminary defence during Opposition procedure
- After filing for Registration not possible to modify application
- Possibility of friendly settlement during Opposition procedure





- Collective Marks
- Addition of new grounds for refusal such as:
 - Geographical indication
 - Appellations of origin
 - Traditional names of wines
 - Names

- Right to alter/correct classification during Renewal Procedure of previously registered TMs
- Single form to be used for multi-applications
- Rejection for part of goods or services
- Simplification of transfer procedure





- Opposition Before Registration
- Revocation/Cancelation After Registration
- Oral hearings to be held in exceptional cases





- Publication in Department's website not in the Gazette
- NO MORE POWER OF ATTORNEY DOCUMENTS TO BE FILED
 - Declaration by Lawyer on each form
