Its seven floors are built around a giant glass atrium shaped like a pint of Guinness, a striking architectural statement that blends industrial history with modern design. Since its transformation into a visitor experience in 2000, the Guinness Storehouse has welcomed millions of guests from around the world. Each floor explores a different part of the Guinness story, from brewing and advertising to tasting and brand history. The visit culminates in the Gravity Bar, offering panoramic views of Dublin.
